- 1) **I AGREE** to observe and obey all posted rules and warnings which may be present at the location of the Class, and **further agree** to follow and abide by any verbal and/or written instructions or directions given by the SAC in connection with the Class.
- 2) I UNDERSTAND that my participation in the Class can be dangerous and involves the risk of property damage, personal injury and even death. I further understand that there are inherent risks associated with participating in the Class, both known and unknown, including, but not limited to, variations in terrain and surface and subsurface snow conditions, avalanches, thin snow cover, the existence of, and collisions with, natural or manmade objects and/or other participants in the class. I expressly assume any and all risk of injury or death associated with my participation in the Class.
- 3) I FULLY RELEASE the SAC and the UNITED STATES FOREST SERVICE, an agency of the U.S. Department of Agriculture ("USFS"), and their collective subsidiaries, parent companies, affiliates, agents, assigns, directors, employees, officers and agents FROM LIABILITY AND AGREE NOT TO SUE the SAC and the USFS for any and all claims and/or causes of action arising from my participation in the Class, even if said claims or causes of action arise from the SAC's and/or USFS's alleged negligence. I further agree to release the SAC and the USFS from any and all liability arising out of my use of, or presence at, any other facilities used by the SAC in connection with the Class, whether caused by the fault of myself, the SAC, the USFS, or other third parties.
- 4) I AGREE to hold harmless, indemnify and defend the SAC and the USFS, and their collective agents, employees, directors, officers, subsidiaries and parent companies against all claims, causes of action, damages, judgments, costs or expenses, including attorney's fees and other costs, which may in any way arise from my participation in the Class or my use of, or presence at, any other facility used by the SAC or the USFS in connection with the Class.
- 5) **I AGREE** to pay for all damages to the facilities used by the SAC and/or the USFS in connection with the Class which are caused by my negligent, reckless, or willful actions.
