Snowmobile Avalanche Awareness Program: California State Parks Grant 2013/2014

Deliverable Update-

- 1. Modify existing snowmobiler avalanche education curriculum developed by sister avalanche centers in the Western US and adapt it for the Sierra Nevada. Completed and submitted in first quarterly report.
- Implement at least three snowmobiler avalanche certification training courses during the 2013/2014 winter season.
 Completed successfully! Program Manager has attached course evaluation feedback received to date.
- 3. Install at least three interpretative signs and safety equipment check stations at popular snowmobile trailheads throughout the Yuba Pass to Ebetts Pass region that SAC covers.

Signage has been developed and Beacon checkers have been received via ARVA. Signs were not installed due to lack of snow this season. They will be installed at the beginning of next season

4. Advertise our program through the development of Public Service Announcements for television and radio, social media, via our website and attending community events.

Sierra Avalanche Center staff has advertised this program via radio (NPR and KTKE), social media and via an e-news letter to existing members. A PSA is in draft form and a poster is being developed currently. In addition, the SAC Program Manager has attended the California Nevada Snowmobile Association Convention and been in correspondence with regional clubs and manufacturers to broaden the campaign's reach and effectiveness.

Grant Proposals Submitted In March:

California State Parks Off-Highway Vehicle Program 2014/2015-

A Pre-proposal to California State Parks was submitted on March 1st. Final notice of awards will be made by July 4th, 2014. The following deliverables and budget were proposed:

- Implement 2 snowmobile avalanche education courses during the 2014/2015 winter season.
- Install 2 additional interpretative sign kiosks at popular California Trail heads (Blackwood Canyon Snow park and trail head near Bassets on Hwy 49)
- Create an informational video to highlight topics covered in the course and show the importance of taking an avalanche course with real world application to promote and publicize the importance of this information share with the snowmobile community
- Create Snowmobile specific educational content on SAC's web page that links our program with the National Avalanche Center's Snowmobile avalanche awareness website
- Advertise our program and raise awareness through;
 - Continuing to air the PSA developed in 2013/2014 throughout the winter and in high exposure during peak holiday weekends to reach a larger audience on cable networks and radio stations appealing to our core audiences in the Bay Area, Tahoe, Truckee
 - Attend at least 2 Snowmobile club events and present at least 2 basic awareness presentations at local snowmobile shops
 - o Distribute outreach materials to all regionally based California clubs
 - Implement social media campaign and Google Ad words campaigns to promote classes and promote avalanche awareness with our target audience
 - Work directly with snowmobile distributors to ensure that this safety message is disseminated to all customers.
- Implement a weekly snowmobile patrol to directly interact with snowmobilers while they are riding in avalanche terrain and collect snow pack data in areas frequented by snowmobiles.
- Create and disseminate a daily avalanche forecast that not only details the specific avalanche hazards and the location of these hazards on any giving day but also serves as a daily educational tool for the community.

Nevada State Parks Recreation Grant 2014/2015-

A proposal was also submitted to NV State Parks on March 7th. Recipients will be notified by June 2014. The SAC Program Manager is slated to give a presentation to the selection committee on April 3rd. The following deliverables and budget were proposed:

Parasol Community Grant Fund-

The Program Manager submitted an unrestricted grant request to the Parasol Community Foundation on March 14th. Average grants are in the \$5k range and if awarded can be used for general operations. There was not a budget form required for this grant proposal. Award notification should be made by May 2014. It is the suggestion of the SAC Program Manager that if awarded, these funds be used for Board development/Non-profit due-diligence items; such as, updating the Strategic or Business Plan, bolstering accounting with an annual non-profit audit and development of a Budget to Actual, Board training in fundraising etc. Parasol has expressed an interest in seeing SAC strengthen in these arenas.

Lahontan Community Foundation-

The SAC Program Manager submitted a proposal to the Tahoe Truckee Community Foundation on March 3rd to develop and implement a "Know Before You Go," youth avalanche awareness program in the Truckee Unified School District. Award notice should be made by May 2014.

If awarded the Lahontan Community Foundation Grant, Sierra Avalanche Center (SAC) intends to present a 50 minute assembly presentation by a local avalanche professional explaining the basics of avalanche knowledge to all Truckee Unified Middle and High School students (4 schools in total).

The goal of the project is to provide young adults with the preliminary knowledge to encourage further education prior to venturing out in to the backcountry. Our larger goal is a ZERO fatality rate from anyone whom SAC has instructed.

The steps to accomplish this project include putting the presentation together and compiling associated collateral/schwag to engage students, working with schools to arrange the assembly, investigating other sponsorship partner opportunities (such as local ski resorts) to possibly assist in a complimentary field component and finally conducting a survey to monitor knowledge attainment.

This project is slated to commence during the fall 2014 and conclude winter 2015. If notice of award is received prior to this time, and still during the school year, SAC staff will begin outreach and planning with the individual schools.
